Review of PRESS Issue 108

Dr. Russell reviewed the policy manual updates recommended by the IASB's PRESS service. Issue 108 is the largest ever, in response to a flurry of legislation passed. The committee reviewed more than half of the draft policies and will complete its review at its February 1st meeting.
