#### **Policy 7:90 – Release During School Hours**

Dr. Russell shared a draft of rewritten language to clarify current practice that students will not be released from school during the school day unless an adult signs the student out at school.

For safety and security reasons, students will not be released from school premises or activities during school hours except (1) to the student's custodial parent/guardian after the parent/guardian has signed the student out at school or (2) to an adult other than a custodial parent/guardian, with the custodial parent/guardian's written permission and after the designated adult has signed the student out at school.

The committee discussed whether written permission is necessary to release a student to a designated adult, or if verbal permission or voicemail would be sufficient.

The central office will consider this input in finalizing a draft for the committee to review.

## **Policy 4:60 – Purchases and Contracts**

Todd Drafall shared that current policy provides that any purchases or contracts under \$25,000 are not subject to bidding requirements or Board approval. For construction, that threshold is \$50,000. However, the District is considering modifying the policy to permit larger purchases or contracts related to referendum construction, when it would be inefficient to wait until the next board meeting for approval. The committee suggested including a sunset provision so that this modification would only accommodate the referendum construction project.

### **Adjournment**
