Approval of Minutes

Abhay Shah moved and Fanny Vlahos seconded the motion to approve the minutes of the December 13, 2022 committee meeting. Motion carried.

PRESS Issue 111

Dr. Russell noted that the majority of the updates in this PRESS issue are due to *Faith's Law*, which provides guidelines for appropriate conduct of educators and requirements for reporting abuse and neglect, as well as requirements for hiring staff. The committee then reviewed and discussed the following policies:

- 6:135 Accelerated Placement Program removes language only applicable to high school districts
- 6:210- Instructional Material 5-year review
- 6:230 Library Media Program omits optional language regarding adopting ALA Library Bill of Rights
- 8:20 Community Use of School Facilities legal references updated
- 8:70 Accommodating Individuals with Disabilities 5-year review

These policy updates will be recommended to the Board for first reading at the May 8, 2023 board meeting.

Policy 7:270 – Administering Medicines to Students

Dr. Russell shared a draft update to Policy 7:270, which adds a paragraph regarding the school district supply of undesignated opioid antagonists (naloxone hydrochloride). This language has been recommended by the county and District nursing staff so that schools can be prepared in the event a student, staff member or visitor experiences an overdose. Nursing staff would provide training to the rest of staff.

Policy 5:330 - Sick Days, Vacation, Holidays, and Leaves

The update to this policy removes a suggested chart regarding vacation days because it is not aligned with District 58 collective bargaining agreements and employee handbooks. The remainder of the changes in the policy align with recent legislation.
