## **Update from Planning Team**

# **Review of Timeline for Strategic Planning**

- Online survey: Jan. 8 27, 2018 (possible laptop stations at Science Fair, DGCC concerts, public library story time)
- Focus groups: Jan. 22 & 24, plus possibility of Saturday Jan. 27
  - o Possibility of a 1 ½ week days, ½ Saturday
  - Scheduling of staff sessions should account for needs of support staff in covering buildings
  - o Should union leadership be separated by union, or all together? (Share similar issues, but may be more forthcoming if separated by union)
- Mar. 1st Meet & Confer meeting has been changed to Mar. 8, 2018.
- The Committee also discussed potential stakeholder groups to invite to focus groups:

- Former BOE members
- o Preschool parents (including DG Christian School, Lincoln Center)
- o Faith leaders or members (only within DG boundaries, or wider outreach to capture communities who travel to their places of worship)
- o Private schools who share Title I funding with D58
- o After-school groups
- Apartment buildings
